In order to keep the campus safe, state law allows students and/or personal property (lockers, bags, backpacks, purses, vehicles, etc.) to be searched whenever a school authority has reasonable suspicion that a student is in possession of illegal or unauthorized materials. Please realize that parental permission or presence is not necessary for this to occur. RRPS Board policy permits random searches in certain circumstances, including a canine search. Unauthorized or illegal items found are subject to seizure.</p>
